When you access our website, subject to your consent when it is required, we (or our partners) may install different categories of cookies and other tracking technologies on your device to recognise your device's browser for as long as the cookie concerned is valid.

You are invited to read this policy carefully before using this website to understand how we use cookies and how you can manage them.

1. What is a "cookie"?

A "cookie" is a small file that our website asks your browser to store on your device (computer, smartphone, tablet, etc.), when you visit this website.

Thanks to the cookie, our web server is able to present you customized web pages that best fit your needs in order to make your experience on our website more personal. We also use third party cookies as indicated in this policy, which are cookies from a domain different than the domain of the website you are visiting, for our advertising and marketing efforts. Some cookies are important for the functionality of this website and are automatically activated when the user visits the website. Some cookies allow us to provide the user with services and functions that best suit their needs, and to tailor our service to them to ensure easy and fast operation of the website.

2. How are you informed?

If you do not agree to the setting of individual cookies, you can deactivate the respective cookie by clicking the provided link. If there are no direct links to deactivation for some cookies, you can restrict the use of cookies in your browser settings.

4. What categories of cookies does this website use and for which purpose(s)?

We may use the following categories of cookies on this website:

- Essential cookies
- Marketing cookie
- Social Media cookies
- Audience/Performance cookie

Session cookies are temporary cookies that are stored in the cookie file of your browser until you end your browser session.

Persistent cookies remain in the cookie file of your browser for a longer period. This time period will depend on the choice you make in the settings of your internet browser. Persistent cookies allow information to be passed to a web server each time someone visits the website.

(i) Essential cookies enable our users to navigate the website and use its features. These cookies cannot be switched off in our systems. Without these cookies, for example login, will not be possible.

We use **essential cookies** to:

- Ensure that the web page functions are executed correctly,
- Allow you to store information about a form that you might have filled in on our website or products, services or information you have selected on our website
- Allow you to access your personal areas on our website
- Adapt the website appearance in accordance with your preferences (language, format etc.)
- Implement security measures when you sign in
