

A JOYRIDE DOWN THE PATH OF GIVING: STAND TO WIN LUCKY DRAW

TERMS AND CONDITIONS

1. These terms and conditions (“Terms and Conditions”) shall apply to the **A JOYRIDE DOWN THE PATH OF GIVING – STAND TO WIN LUCKY DRAW** (“Lucky Draw”) organised by Republic Auto Pte Ltd (“Republic Auto”).
2. By taking part in this Lucky Draw, you agree to be bound by these Lucky Draw Terms and Conditions and the decisions of Republic Auto in relation to and in connection with this Lucky Draw.

PROMOTION MECHANICS

3. Participant(s) who purchase and register any pre-owned passenger or commercial vehicle from Republic Auto will receive one (1) lucky draw chance. Each participant is eligible for one (1) chance per vehicle purchased and registered.
4. Participant(s) who purchase and register any pre-owned passenger or commercial vehicles originally purchased from Cycle & Carriage Singapore from the following brands: Mercedes-Benz, Kia, Mitsubishi, Citroën, DS Automobiles and Maxus, will be eligible for two (2) chances per vehicle purchased and registered.
5. To be eligible for the Lucky Draw, each participant must have entered in to a valid Sales Agreement and obtained a booking receipt from Republic Auto and submitted to the Lucky Draw the same personal identification details as in the Sales Agreement and booking receipt.
6. The Lucky Draw is only applicable for showroom retail sales transacted at Republic Auto’s showrooms at 209 Pandan Gardens, Level 3, Singapore 609339 and 239 Alexandra Road, Level 2, Singapore 159930.

QUALIFYING PERIOD:

7. Only persons who have purchased and registered a pre-owned passenger or commercial vehicle with a valid Sales Agreement and booking receipt from 20 December 2021 to 28 February 2022 (both dates inclusive) are eligible to participate in the Lucky Draw.
8. Republic Auto reserves the right to amend the qualifying period.

ELIGIBILITY:

9. Each participant must be 18 years and above (as of the start of the Qualifying Period) and must reside in Singapore.
10. The following categories of persons are not eligible to participate in the Lucky Draw:
 - i. All permanent and/or contract employees (“Employees”) of Republic Auto, Jardine Cycle & Carriage Limited and its subsidiaries and affiliates (“JCCL”) and their immediate family members (i.e. spouses, children, parents, brothers and sisters) (“Immediate Family Members”).

- iii. All dealers and/or distributors of the products of the Republic Auto, Jardine Cycle & Carriage Limited and its subsidiaries and affiliates ("JCCL") and their employees and immediate family members.

11. Republic Auto has the absolute discretion to determine the eligibility of participants. Such determination shall be final and conclusive and Republic Auto is not obliged to give any reason for its determination.

PRIZES:

12. There will be three (3) lucky draw winners and the prizes ("Prize") are:

- i. First prize: S\$3,000 worth of Service Credits
- ii. Second prize: S\$2,000 worth of Service Credits
- iii. Third prize: S\$1,000 worth of Service Credits

13. The Prize will expire on 31 December 2023.

14. Republic Auto reserves the right to, at any time and in its sole and absolute discretion, replace and/or substitute any of the prize(s) with any other item of a similar value.

15. The winners for the Lucky Draw ("Winners") will be drawn at random on 2 March 2022 ("Draw Date") at 11am. The draw will be located at 301 Alexandra Road Singapore 159968.

16. All Winners shall be notified by phone at their phone number, email address and ordinary post at their mailing address as indicated in the Sales Agreement within fourteen (14) calendar days of the Draw Date.

17. Personal identification (NRIC or passport) with details matching the participant's personal identification details in the Sales Agreement must be presented to the authorised Republic Auto representative for verification in order to redeem the prize.

18. If a Winner fails to produce the required personal identification documents, his/her respective prize will be forfeited (without any liability on the part of Republic Auto to any person).

19. Prizes that are not redeemed within thirty (30) calendar days from the Draw Date will be forfeited. No correspondence or claims will be entertained in the event of such forfeiture. A participant whose prize has been forfeited shall not be entitled to any payment or compensation whatsoever from Republic Auto.

20. Reserve winner(s) will be drawn to replace any winner(s) subsequently disqualified.

If Republic Auto discovers that a Winner was not entitled to participate or if a Winner is subsequently disqualified from participating in the Lucky Draw, Republic Auto may at its discretion forfeit the Prize and then choose an eventual winner from the reserve winner list or donate the Prize to MINDSET Care Limited, a registered charity of the Jardine Matheson Group in Singapore.

 - ii. receive customer surveys and information about promotions, events and products and services ("marketing and promotional information") from JCCL; and
 - iii. the collection, use and disclosure of its personal data for such marketing purposes by JCCL and its agents.

Notwithstanding the above, marketing and promotional information may be sent to the participants (including the Winners) by push and/or pop-up notifications through JCCL's mobile application(s) should the participants (including the Winners) install the application(s) on their mobile device. The participants (including the Winners) shall agree that by enabling push and/or pop-up notifications in their devices or mobile application settings, they have consent to receiving such marketing and promotional information.

27. Participants (including the Winners) are deemed to have read and understood the Privacy Statement and been acquainted with their right to access their personal data.
28. Participants (including the Winners) are deemed to have check and confirm that the personal data they have provided is true, complete and accurate.

OTHERS:

29. The decisions of Republic Auto on all matters relating to or in connection with the Lucky Draw are final, conclusive and binding. Republic Auto shall not be obliged to give any reason or enter any correspondence with any person on any matter concerning the Lucky Draw.

Republic Auto reserves the right at any time in its sole and absolute discretion to determine and/or amend or vary these terms and conditions without prior notice, including but not limited to cancelling, extend, terminating or suspending this Lucky Draw, the eligibility terms and criteria, the selection and number of winners, and the timing of any act to be done, and all participants shall be bound by these amendments.

Republic Auto shall not be responsible for any injury, loss or damage suffered as a result of, or in connection with the Lucky Draw and/or redemption or use of the Prizes howsoever arising, including but not limited to, fulfillment of the prize(s), any error in computing chances, any breakdown or malfunction in any computer system or equipment, any notice which is misdirected and/or lost in the post, loss of income, profits or goodwill, direct or indirect, incidental, consequential, exemplary, punitive or special damages of any party including third parties howsoever arising whether in contract, tort, negligence or otherwise.
